## Renewable Energy Purchase Agreement for Large Business Customers



**The Energy for Tomorrow program gives customers the opportunity to purchase electricity generated from renewable energy resources such as wind, water, solar and biomass.**

All rates and conditions of delivery of the respective rate schedule under which the customer is served are applicable.\**

**We Energies will:**

- Provide renewable electric energy in the amount requested above.
- Deduct the Fuel Cost Adjustment (FCA) from customer's electric bill for each kWh of renewable energy purchased.
- Provide the customer with renewable energy information.
- Maintain independent certification of renewable energy purchases.
- Provide the customer with public recognition of their commitment.

**Customer will:**

- Purchase renewable electric energy in the amount requested above from Energy for Tomorrow for one year. Purchase requirement will automatically renew each year unless terminated by the customer or We Energies in writing 30 days prior to the contract expiration date.
